#### CLASS 1962 DONATES \$10,000.00 FOR FEU-NRMF SIMULATION ROOM

The graduating class of 1962 gifted our alma-mater FEU-NMRF the sum of \$10,000.00 to improve the Simulation Room at the school. Due to COVID19 pandemic and the ensuing modified enhanced community quarantine imposed by the Philippine government to contain the spread of the virus, FEU-NRMF's teaching is now online using the Moodle-based Learning Management System. Blended learning will be implemented when face-to-face encounter is allowed per DOH/ IATF recommended health standards to prevent COVID-19 transmission. Without an increase in tuition fees, FEU-NRMF still needs to improve LMS so that the faculty and students alike will achieve optimum educational outcomes.

FEU-NRMF Dean de los Reyes stated "Because of the online learning, our school has to invest a lot to update and enhance our LMS. However, the school did not increase the tuition fee. Since March 2020, our faculty were busy with faculty development activities as we transition to the new normal in teaching, that is online or remote teaching and learning (RTL). I even have to enroll in a course in UP Open University on RTL last May. This is really a very challenging time. I am very happy that the renovation of our Simulation Lab will now push thru with the assistance of Class '62 through Dr. Daisy Ramos. This will be a valuable addition to our online learning armamentarium. We will start the renovation as soon as we receive the donation of Class '62".

This generous gift is a product of the collective effort of Class 62, and was supported by Class Dr President Fidel Exconde and Past Chairman of the FEUDNRSMAF Board Dr Noli Guinigundo. Driven by the focused determination of FEUDNRSMAF Past Secretary and current Co-Chair of the FEUDNRSMAF Fundraising Committee Dr Daisy Ramos, the journey to raise the \$10,000.00 donation to the school was finally made a reality. In addition, Dr Daisy Ramos, as Co-Chair of the FEUDNRSMAF Fundraising Committee, has over the years devotedly donated her time, treasure and talent to fund the Scholarship Program through the annual sales of raffle tickets.



#### WE HAVE ZOOM!

We adapted to the new normal! The FEUDNRSMAF Scholarship Committee subscribed to ZOOM, and interviewed all prospective scholars and financial grantees (economic hardship) via ZOOM teleconferencing.

**So what is Zoom Meetings?** It's a video conferencing platform that allows groups to have online meetings safely without face-to face encounters. The ZOOM software allows for HD video as well as audio and supports up to 1,000 participants per session, depending on the membership subscription plan. Participants can join in from a computer or a mobile device anywhere in the world as long as they have an internet connection. They can turn on their cameras so others can see them or keep them off in case they want privacy. Each individual can also turn off their microphone as well to make sure there are no background noises when someone speaks.

**So what does this mean to FEUDNRSMAF?** This means that the members of the Executive Committee, Committee and Chapters can now easily join a meeting, in the safety of our homes using the Foundation personal ID and password. You can also schedule a meeting with FEUNRMF and FEUMAS. Our subscription membership allows to have a meeting of up to 100 participants with duration limit of 24 hours. The software also has recording capability of 1G cloud recording.

**FEU-NRMF's Strategies in Response to Today's Educational Challenges:** Rey H. de los Reyes, M.D., Dean, School of Medicine Class; Joaquin Jose L. Reyes, Chief Information Officer; Robert Dy, M.D., Chairman, Department of Otorhinolaryngology-Head and Neck Surgery and Chair, Online Learning Committee Class '96; Arnold Bautista, M.D., Chairman, Department of Anesthesiology and Co-Chairman, Online Learning Committee Class '89

In response to the COVID19 Pandemic, the FEU-NRMF School of Medicine relied on its learning management system, Moodle, to address the online needs of our students. Moodle is an acronym for "Modular Object-Oriented Dynamic Learning Environment" was started in 2016. It is a Learning Management System (LMS) where faculty can create lessons, manage courses and interact with students. FEU-NRMF Moodle is a learning platform that is accessible to all enrolled students, from anywhere, at any time. Learning will remain consistent, engaging and individualized.

Luckily we had Moodle in place and integrated with our School Information System when the pandemic hit, so we could activate Moodle courses fairly quickly. One of the initial responses that was probably as important as any we've done is to open up various support channels (Telegram group helplines, Facebook FEU-NRMF IT Department support page).

Some major challenges we faced:

- Not being sure how long the class suspensions would be and how much of a role our LMS would need to play,
- The sudden explosion in level of usage in Moodle from less than 5% of subjects to most students/ subjects lead to a lot of stability issues, and
- Getting faculty and students up to speed on the transition to online learning tools (technical knowhow, connectivity and devices).

It became apparent after the midterm exams that the Moodle quiz module would require significant changes. The Moodle quiz module was not specifically designed for remote access or at least not for the type of connectivity challenges that many of our students faced.

During the lockdown, we had students back in their provinces with poor and unstable internet connection. The school implemented the Fault Tolerant System for the examination module of Moodle which is designed for low bandwidth and unstable internet. It allows students to take the exams without worrying about connectivity. The examination can be taken even totally offline and can be submitted a few hours later once the internet supply became.


#### Our response:

- Scheduling of exams to prevent / minimize server congestion,
- Dashboard to monitor quiz/exam settings, schedules and takers progress,
- Heavily customized fault tolerant guiz module for Moodle to address several exam issues raised by students
  - \* page loading times,
  - \* ensure that all answers get saved,
  - \* allow students to continue taking exams even when their internet connection becomes unstable or even completely goes down,
  - \* question validation to prevent students from skipping questions.

Moodle plugins to expand the functionality / integration of Moodle (some available from Moodle some custom built)

- Zoom meetings plugin
- Embedded PDF viewer
- Image optimizer

One of the biggest factors in the improvement from last semester to now was the commitment to training. The Moodle and zoom boot camp was really crucial to upgrade the online experience of the faculty. The commitment of the trainors and buy-in /cooperation from the various faculty / departments has to be commended. We got a major boost when the administration approved the site wide zoom license providing all faculty and students zoom licenses for online lectures and discussions. In addition, we were able to roll out G-Suite for all students, faculty and staff. They were named as ASTRA accounts by Dr. Robert Dy, coined from FEU-NRMF's motto "Ad astra per aspera" meaning "To the stars through difficulties" and the three stars in our logo symbolizes our goals of reaching excellence in Training, Service and Research. Now, we are sure that everyone has access to various online tools / apps that are crucial with the shift to online / remote learning.






There were also a lot of processes that needed to be made available online or improved: grading integration with Moodle, expanding / improving the online enrollment process flow especially for irregular students, creating an online bookstore and providing electronic delivery of learning materials.

We've come a long way, but we are still eyeing a lot of other improvements:

- \* Enhancements to the quiz/exam dashboard to automate common tasks
- \* Automate the attendance process so it can download meeting reports from zoom provide an facility to add asynchronous activities and be able to connect this with teaching load
- \* SMS / Email notifications for new content posted in Moodle courses or just to get announcements out
- \* Improvements to online transactions especially when it comes to payment channels
- \* Add more processes to the student portal for things like applying for LOA or withdraw from specific subjects
- \* Backend work to improve server stability and uptime

#### Offered other school services online.

  - C. Clinicalkey medical search engine and database tool owned by medical and scientific publishing company Elsevier.
  - D. Turnitin originality checking and plagiarism prevention service that checks your writing for citation mistakes or inappropriate copying.
  - E. Proquest a journal and literature search engine
- 2. Online "KAMUSTAHAN" is an online platform offered by Guidance and Counseling Office which aims to sustain a helping relationship with the students amidst crisis. Specifically, it shall help students understand their current experiences and help them cope with the situation. The interventions that we are currently implementing are follow-up with students, conference with parents/guardian, consultation and collaboration with faculty members and specialist/psychiatrist/psychologist through various on-line modalities.

#### CLINICIAN'S CORNER: Basic Medical Economics John Ivan Sutter, MD, MS, FAAP Class 1978

As physicians, we are never taught some of the basics of management of the office or more appropriately described as our business. There are numerous principles that one must learn to truly be a manager and become successful in medicine. Regardless of specialty and payments, one must analyze both costs and income for the business. Costs come in 2 categories-fixed such as your monthly rent and utilities and variables such as medical supplies and payroll. To improve your cash flow and properly determine a budget there are several ways of approaching this. One is to keep a fixed payroll although in primary care that is difficult due to seasonal fluctuations. Office supplies on the other hand can often be fixed to a large degree when dealing with suppliers and vendors. It is an easy task for most vendors to create a spread sheet of

the supplies you have ordered from them over the past 6 to 12 months and one can use this to create an inventory spreadsheet. Most vendors will likewise be willing to put you on a standing order arrangement based on your past usage so that orders are sent out automatically every 1 or 2 months. This will create a more streamlined approach to your payables. This is the simple way to analyze your expenses and turn variable costs into fixed ones and thus creating a mechanism for budgeting your expenses for a period of time.

On the income part of the business, things are often more complicated and variable depending on your payor mix and patient responsibility. With several large payors you are able to now get a fixed revenue stream set up based on past claim history with true ups quarterly. The greatest variable in revenue is with the patient responsibility. It is imperative that you receive any copayments and expected coinsurance at the time of the visit. Once the patient leaves your premises, it becomes increasingly difficult to capture payments. I am deliberately avoiding the term reimbursement here as reimbursement implies you have a cost and are getting paid for that cost. We should never consider payments from the patient or the insurance carrier as reimbursement for this reason. So how do you collect money once the patient has left the office. As part of your financial policy for your business, you should include credit card information. Now to avoid potential dangers from hacking and misuse of your patient financial information, it is best that this be stores in the "cloud" or thru any one of several vendors that offer this service at minimal cost. Then once your receive the explanation of benefits it is easy to collect, Simply notify the patient via text or phone of your intent to bill them the amount owed and send them a copy of the receipt for their records.

The problems arise when the information is not correct whether on the initial registration or an expired credit card. Once balances have been carried for more than 30 days, it becomes exponentially more difficult to collect. Another aspect of your patient registration form must include wording to reflect a delinquency fee to be applied after x number of days and that any costs related to collecting moneys due are their responsibility including collection agency fees or court costs just like any other contract you have received in your business.

Now what do you do with the seriously delinquent patient? Most of us have used collection agencies for years and receive a meager fraction of these late payments and then are forced to pay upwards of 40% to them in fees. You do however have another option which in my personal experience has proved quite rewarding. Within each State, courts are divided into various branches and the lowest of those are intended to handle simple civil cases without the need for a lawyer. In some states they are specifically referred to as Special Civil Counts (think of Judge Judy). In these or other civil courts, you can file a claim easily on line and pay a small filing fee and attach a copy of the patient bill plus filing fees and a fixed service charge. Once filed, you will receive a written notice for the date of a hearing before a Judge to listen to your case. Similarly the patient receives a notice of your action as a suit for money owed and the date for the hearing. In the overwhelming majority of the cases, your patients will miraculously appear with the funds owed. If not, you or a designate representative, i.e. office manager will have to appear and present your claims for the money owed. In most cases, this is simply a legal matter that quickly gets agreed on by the Judge and the patient has no recourse but to pay. If they do not, you simply notify the Court of this and they refer the matter to the local Sheriffs office for action. Of all the times, I have resorted to this, less than 30% of patients wait until the court date and only a handful do not pay. Depending on the State, there are monetary limits for this sort of case but it is usually less then \$25,000.00. It is actually possible to perform this same action against an insurance carrier if you are facing a breach in their obligation to pay. 
**National Childhood Obesity Awareness Month** provides a chance for all of us to learn more about this ongoing serious health condition. While there is no simple solution, there are many ways communities can support children with their journey to good health.

Childhood obesity is a continuing serious problem in the United States putting children and adolescents at risk for poor health. Obesity prevalence among children and adolescents is still too high. This problem is greatly impacted during this time because of stay at home orders and school closures due to the 2020 COVID19 pandemic. Obesity is defined as a body mass index (BMI) at or above the 95th percentile of the CDC sexspecific BMI-for-age growth charts. Access growth charts to use in you practice at :https://www.cdc.gov/growthcharts/clinical\_charts.htm

Obese children become obese adults. Between 2003–2004 and 2013–2014, there were no significant changes in childhood obesity prevalence, but adults showed an increasing trend. Overall, the prevalence among adults aged 40–59 (42.8%) was higher than among adults aged 20–39 (35.7%) in 2015–2016.

The map below shows the Prevalence<sup>†</sup> of Self-Reported Obesity Among U.S. Adults by State and Territory, BRFSS, 2018. Combining data from 2016 through 2018, non-Hispanic blacks had the highest prevalence of self-reported obesity (39.1%), followed by Hispanics (33.3%) and non-Hispanic whites (29.3%).

The key findings from the National Health and Nutrition Examination Survey (pdf CDC National Center for Health Statistics (NCHS) data brief ):

- ♦ In 2015–2016, the prevalence of obesity was 39.8% in adults and 18.5% in youth.
- ♦ The prevalence of obesity was higher among middle-aged adults (42.8%) than among younger adults (35.7%).
- ♦ The prevalence of obesity was higher among youth aged 6–11 years (18.4%) and adolescents aged 12–19 years (20.6%) compared with children aged 2–5 years (13.9%).
- The overall prevalence of obesity was higher among non-Hispanic black and Hispanic adults than among non-Hispanic white and non-Hispanic Asian adults. The same pattern was seen among youth.
- ♦ The observed change in prevalence between 2013–2014 and 2015–2016 was not significant among both adults and youth.

BMI measurement, using height and weight, is the recommended screening test for obesity. Obesity is defined as an age- and sex-specific BMI in the 95th percentile or greater.
Comprehensive, intensive behavioral interventions of ≥26 contact hours resulted in weight loss. Effective interventions consisted of multiple components, including: sessions targeting both the parent and child (separately, together, or both); offering individual sessions (both family and group); providing information about healthy eating, safe exercising, and reading food labels; encouraging the use of stimulus control (eg, limiting access to tempting foods and screen time), goal setting, self-monitoring, contingent rewards, and problem solving; and supervised physical activity sessions. Providers included primary care clinicians, exercise physiologists, physical therapists, dietitians, diet assistants, psychologists, and social workers, but the more intensive interventions usually involved referral outside the primary care office. Evidence regarding pharmacotherapy interventions was inadequate.
The USPSTF concludes with moderate certainty that the net benefit of screening for obesity in children and adolescents 6 y and older and offering or referring them to comprehensive, intensive behavioral interventions to promote improvements in weight status is moderate.

#### **AMOR FATI**

Mike Tyson famously quipped, "Everyone has a plan until they get punched in the mouth." The former heavyweight champion's, simple yet profound, message stretches far beyond boxing. This is not to diminish the value of planning and preparing for the future. Rather, Tyson knew from experience that even the "best laid plans" can go out the window when faced with sudden and unexpected challenges. COVID-19 has punched the world in the mouth, very, very hard. The question is, how will we respond to the adversity? Some freeze in the face of danger like deer in the headlights, while others relish the challenge and rise to the occasion. Champions are able to draw strength and courage from deep within. Champions are able to adapt, and respond with thunderous punches of their own. True champions

do not shy away from adversity. They thirst for it, for they know that a capable adversary is a necessary component of an enduring legacy.

The world was very different when you enrolled as freshmen. The medical profession already was wrought with risk and challenges, but not to the extent we see today. The pandemic has put the commitment and resolve of medical professionals to the test, and the overwhelming majority has risen to the challenge and redefined what is means to be a hero. Today's heroes don't wear capes or armor. They are draped in PPE and N95 masks. For many of you, this is not what you signed up for. I'm sure your parents did not expect you to be put in harm's way so early in your careers, and yet, here we are. In fact, I can't recall a time when so much was required of so many, so early in their lives. The irony is the knock on your generation is that you are peevish and petulant. Some would even go as far as saying that this generation is soft. Graduates, this is your chance to prove them all wrong.

The Stoics have a saying "Amor Fati," which is Latin for love of fate. It is a mindset that sees everything that happens in one's life, including suffering and loss, as necessary. It goes beyond acceptance, to actually loving all that has happened, even the most tragic.
