The debate on the topic of

And our patients complain about the hard situation in their life, their aches and pain, their depression, their nerves, their

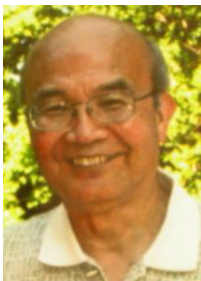

Lady bugs in motion

Reason for CAITLYN JENNER

Sperm From Ovaries

Caitlyn Jenner is not the first and will not be the last of her tribe. She simply has put a punctuation mark on her type.

Some people say it the new normal; but many more still consider gender identity change a dysfunction, or more accurately a disorder, especially from the healthcare perspective.

Gender identity disorder, aka GID, aka gender dysphoria, has no specific cause, but a person's upbringing, hormones in the womb, and genetics might be involved.

In endocrinology, there are also similar and related entities, including testicular feminization, Klinefelter syndrome, Turner syndrome, hermaphrodite, etc. In tumor literatures, ovarian dysgerminoma, testicular Leydig cell tumor, ovarian Sertoli cell tumor are well entrenched and may behave poorly.

Among the identifiable causes, perhaps genetics or more recently genetic engineering may provide the best explanation why Caitlyn Jenner and her kind exit.

Recently, for example, somatic cells in the gonads of a developing vertebrate provide germ cells with cues, such as hormones, to develop into sperm or eggs are observed. Studying the ways these cues affect a germ cell's commitment to become sperm or eggs, workers from the Minoru Tanaka laboratory at the National Institute for Basic

CLINICAL IMAGES

NEUROENDOCRINE CARCINOMA OF THE GALLBLADDER

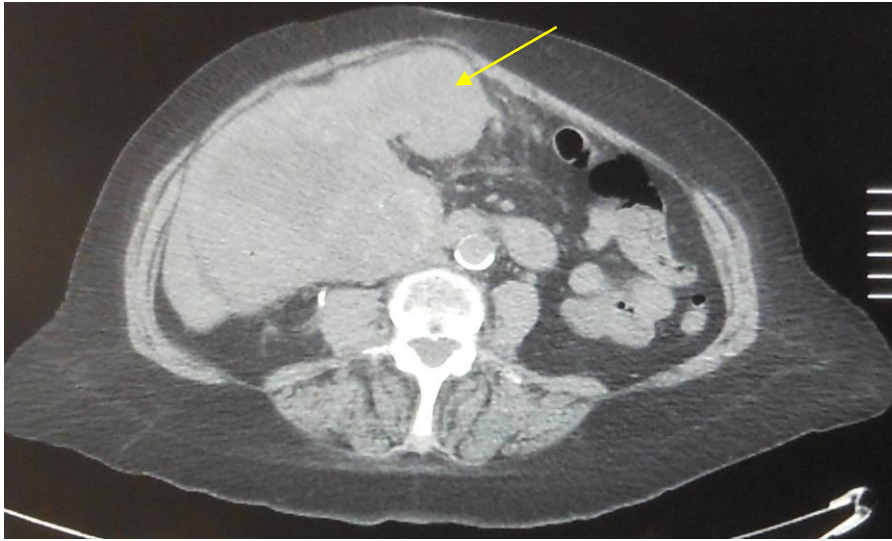


Figure 1 – CT scan shows a large gallbladder mass (arrow)

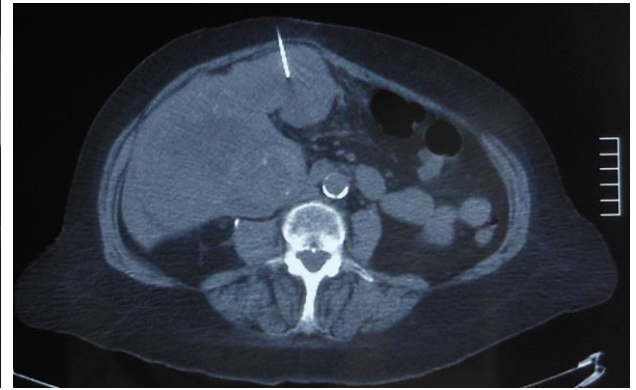


Figure 2 – The fine-needle biopsy is on target on the gallbladder tumor

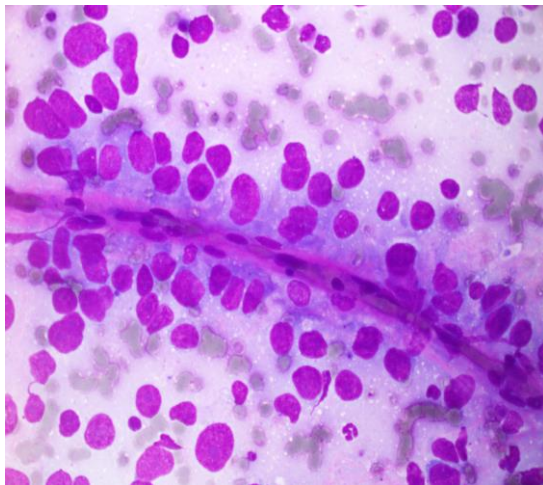


Figure 3 - Undifferentiated small cell carcinoma is perithelial-centric (Diff Quik stain, x200).

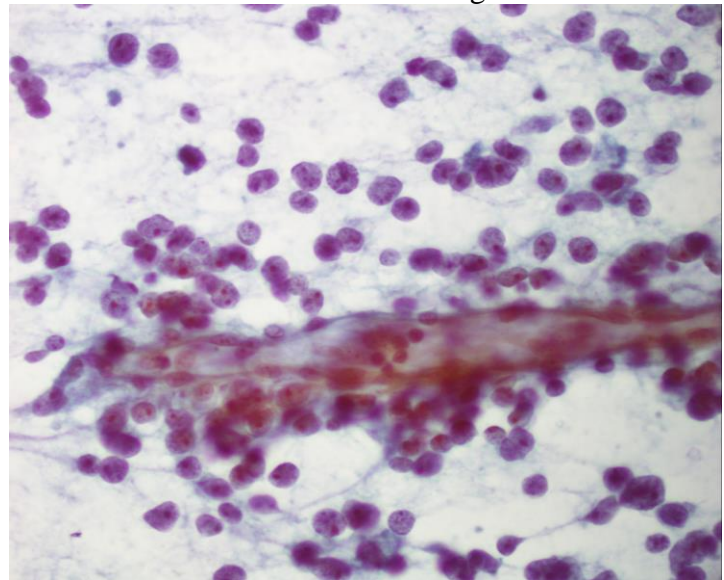


Figure 4 – The neoplastic cells are perithelial, dyscohesive and spread-out (Papanicolaou stain, x200)

The **IMAGES** are an 81-year old female who presented with decreased appetite of three weeks, associated with increasing right upper quadrant abdominal pain. There were no other symptoms and signs.

A computer tomographic scan revealed a large cystic necrotic mass of the gallbladder, measuring 15 x 12 x 10 cm (**Figure 1**), with extension into the adjacent liver parenchyma, without

intrahepatic biliary/ ductal dilatation. Pancreas, adrenal glands and kidneys were normal. No fluid was seen within the abdomen and pelvic cavity.

A CT scan-guided fine-needle aspiration cytology (**Figure 2**) was positive for malignant epithelial cells of high-grade neuroendocrine carcinoma, with a **background necrosis, rosette** and perithelial arrangement (**Figures 3 and 4**).

Immunohistochemical analysis showed negative CAM5.2, CD45, carcinoembryonic antigen, CK20, CK7, glypican3, HepPar1, S100 and TTF-1.

Moderately positive synaptophysin and chromogranin staining proved that the tumor was of neuroendocrine carcinoma.

The patient and her family opted for a hospice; and she was lost for follow up.

COMMENTS and LITERATURE REVIEW.

Neuroendocrine carcinomas (NEC) are postulated to arise from multipotential stem cells that may have migrated from the neural crest to the foregut and gallbladder during embryonic development. The other pathway is based on the fact that normal gallbladder does not contain neuroendocrine cells, and is via the process mucosal metaplasia of the gallbladder, that often accompanied by cholelithiasis and cholecystitis.

NECs are an exceedingly rare malignancy in the gallbladder. A literature search of gallbladder carcinomas has revealed reports of 28 (78%) pure small cell carcinomas and eight (22%) small cell carcinomas combined with adenocarcinomas.

The clinical characteristics of this disease include an increased incidence in the elderly population, female preponderance, association with cholelithiasis, and metastases at presentation as frequent as 75% of the time to the lymph nodes, liver, lungs, and peritoneum.

According to signs and symptoms and behavior of the disease in our index patient, it is consistent with the picture reported among other cases of small cell or neuroendocrine carcinomas of the gallbladder.

In gallbladder carcinomas, adjuvant chemotherapy is often used without a well-defined protocol. Therapeutic interventions are currently limited to complete surgical resection with negative margins.

On the other hand, a resection is feasible in less than 25% of patients because of the advanced stage of the disease at diagnosis. Surgical excision with adjuvant chemotherapy remains the best option to treat a small cell carcinoma of the gallbladder.

The necessity of debulking, or a radical resection and removal of marginal tissue has been debated in the literature.

Although different chemotherapy regimens have been described in patients who are not amenable to curative surgery, to date there is no blinded randomized clinical trial that has validated a particular regimen as the gold standard for treatment.

The prognosis of gallbladder NECs is fairly similar with the pulmonary and extrapulmonary varieties, and appears to be very poor with a median survival in a series of 53 cases with disseminated disease of eight months, a one-year survival rate of 28%, and two-year survival rate of 0%.

In a published review of 32 gallbladder NECs cases, only one case survived for 28 months.

According to another literature study, the median survival time of combined NEC and adenocarcinoma following surgery was reported to be 4.5 months.

In patients who underwent cholecystectomies, the median survival time was slightly better than those who underwent radical tumor resection.

Chemotherapy following surgery also increased the survival time to an average of 13 months.

In **CONCLUSION**, a rare example of gallbladder neuroendocrine carcinoma is illustrated. The diagnosis usually portend a grave prognosis. At manifestation, the tumor is advanced. Debulking and chemotherapy is best regimen, but the response to the regimens remains to be less than desired.

There is no follow-up in our index patient because she and her family opted to hospice.

Biology in Okazaki, Japan, have found a single gene that when missing from female embryos of the Japanese rice fish, or *medaka* (*Oryzias latipes*), leads the fish to produce functional sperm soon after hatching.

That germ cells can genetically determine sexual fate is something new and exciting. Yes, the simple deletion of a single gene, female Japanese rice fish can produce sperm. Or perhaps, vice versa?

At least in *medaka*, spermatogenesis must be suppressed for oogenesis to proceed normally, and that sperm can develop in an ovarian environment.

The gene, *foxl3*, is an ancient lineage duplicate of the *foxl2* gene, which is known to be involved in mammalian ovary formation. But the

function of foxl3 remains unclear.

In mammals, foxl2 is well known to antagonize male somatic cell fate and now foxl3, at least in *medaka*, seems to antagonize male germ cell fate.

In the study, two medaka mutants result in no detectable expression of the FOXL3 protein. In female

fish, and the majority of these fertilized eggs hatch.

Other than producing sperm, the mutant fish are overtly female, and the absence of foxl3 do not affect the development of their surrounding somatic gonadal cells.

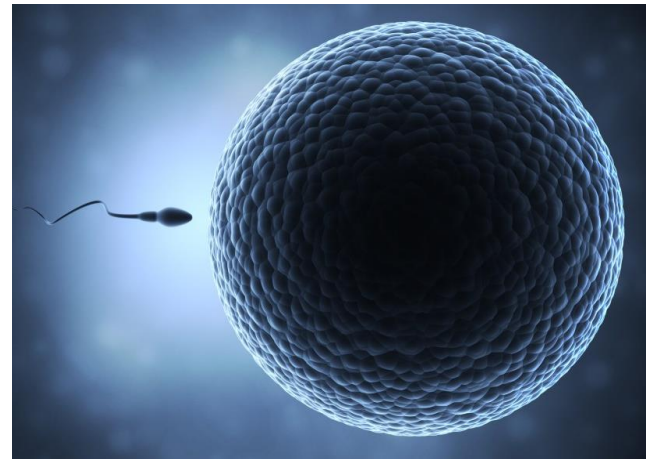
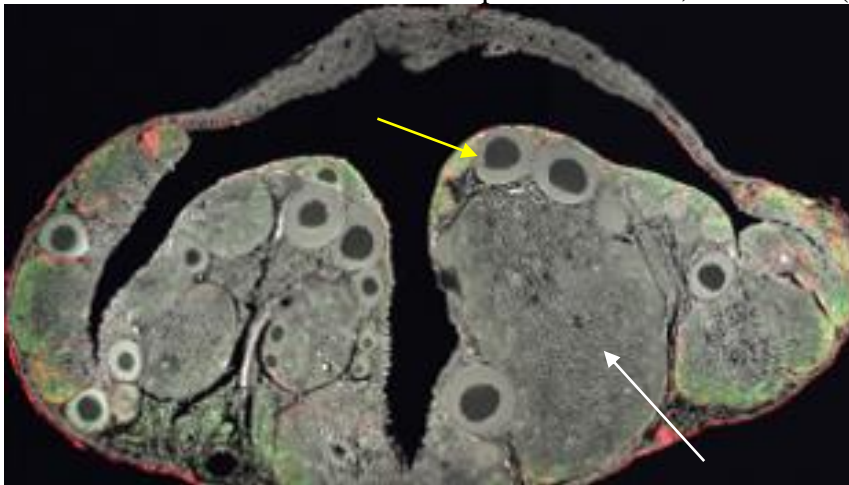
It is also detected that some oocytes continue to be present within the sperm-producing ovaries of some mutant fish.

germ cells in the *medaka* ovary from adopting the spermatogenesis pathway is foxl3. This shows how plastic the sexual fate of these germ cells is in this species.

Furthermore, foxl3 appears to allow female germ cells to react to environmental signals while the mutant is shielded from these gonadal somatic cell cues. That the default

spermatogenesis within the ovary is detectable one week after the fish hatches, three weeks earlier than the typical timing of male puberty, when sperm production starts in these fish.

While spermatogenesis within the ovary is somewhat irregular, the resulting sperm is viable. Extracted ovary-produced sperm fertilizes half of the eggs of wild-type female

Because the sperm can form in the context of female signaling hormones, the results suggest that male germ cells may not register regulatory signals from female somatic cells.

In the environment of a seemingly perfect ovary, the germ cells are largely undergoing the spermatogenesis pathway, suggesting that the only factor normally stopping

development track appears to be male is unexpected, as all of the data from higher vertebrates shows that the default development is female.

Sex determination mechanisms vary greatly among different fish species. Unlike many other fish, in which temperature-dependent mechanisms determine sex, sex determination in *medaka* is chromosomally determined.

It is also unclear whether the results in *medaka* will have any impact on the study of sex determination in mammals.

Additional studies on how *foxl3* is regulated, what it regulates, and how this gene is linked to the factors that determine sex in the somatic cells of the gonads in *medaka*.

Perhaps, the next big thing would be an oocyte genetically produced in Caitlynn Jenner's testis --- if it still there.

independence.

In 1962, the former President Diosdado Macapagal signed an executive order that *moved*

the Philippines's Independence day from July 4 to June 12. He was trying to correct history.

So which of the two dates then is our real Independence Day? Is it the 12th of June 1898? Or is it the 4th of July 1946?

June 12th was not in accord with the Islands' Independence which was recognized on July 4, 1946, as stated above. Invoking nationalism and upon the advice of historians, Republic Act #4166 was signed into law by President Macapagal in 1964, proclaiming June 12, which up to that time had been observed as Flag Day, as Independence Day. Now July

4 is relegated to being Pilipino American Friendship Day.

Since then, there is an ongoing debate on which day should the Philippines really celebrate its independence day.

We have read media headlines titled 117th Philippine Independence Day Celebration here in the United States and in the Philippines recently. Now I come to realize that June 12, 1898, was only a proclamation made by General Emilio Aguinaldo.

A history book titled *Philippine History and Government, Through the Years* by Francisco M Zulueta, and Abriel M Nebres is considered to be a good read.

History tells us that in April 1898 the American-Spanish War ensued. From his exile in Hongkong, Aguinaldo made arrangements with the United States authorities to return to the Philippines and assist the US in the war against Spain. He landed on May 19, rallied his revolutionaries, and began liberating towns south of Manila. Commodore George Dewey invaded Manila Bay and overpowered the lackluster Spanish Navy. The Spaniards eventually surrendered to the Americans.

I wrote in my book two years ago when I opined: On June 12, 1898, in Cavite el Viejo (now Kawit), Cavite, Philippines, the KKK (Katipunan) patriots of General Aguinaldo proclaimed the Philippine Declaration of Independence. With the public reading of the Act of the Declaration of Independence, Pilipino revolutionary forces under General Aguinaldo

proclaimed the sovereignty and Independence of the Philippine Islands from the colonial rule of Spain. However, on December 10, 1898, the Americans annexed the Philippines with Spain by the Treaty of Paris. The Aguinaldo proclamation of Philippine Independence was a questionable proclamation. No sovereign nation have recognized it, was neither recognized by the United States of America nor by Spain, hence became invalid because under this treaty, Spain ceded to America the Philippines, Guam and Puerto Rico, for which America paid Spain \$20 million.

This brought about the Pilipino American War in February 4, 1899. Aguinaldo was captured by US forces on March 23, 1901. Thereafter, Philippines remained an American colony. Although June 12, 1898, seems logical for its nationalistic reasons, borne out and inspired by the events of the Katipuneros' rebellion against Spain culminating with the proclamation of Independence by General Aguinaldo.

However, the Philippines was not truly independent since we continued to be a colony of the United States, and the declaration of Independence was not fully recognized by the international community of nations. Thus, it was not fully legitimized. The struggle for independence continued afterwards. Then there was the interval when the war came and Japan took over the Philippines in the early forties.

Then on July 4, 1946, after the US and the valiant Pilipinos

defeated the Japanese, the United States gave the Philippines its Independence.

It was on July 4, 1901, that Governor General William H Taft declared a complete civilian administration in the Philippines.

On July 4, 1902, U.S. President Theodore Roosevelt proclaimed a full and complete pardon and amnesty to all people in the Philippine archipelago that had participated in the conflict, effectively ending the war.

The Philippines remained an American colony from 1902. A semiautonomous Philippine Commonwealth was inaugurated in Manila with Manuel L Quezon as president and Sergio Osmeña as vice-president in 1935.

The Philippines existed as a commonwealth of the United States, a political relationship. This became the United States-based Philippine government-in-exile during the Japanese occupation.

July 4 was celebrated as Philippine Independence Day. For Pilipinos, the Fourth of July became the true Philippines Independence Day celebrated every year for 15 years. This is the date that I remember celebrating Independence Day when I was growing up in the Philippines. I tend to favor this date when talking of independence since this is when we were able to govern ourselves. We attained some political independence. We have self-rule however imperfect or hellish it might be, as President Quezon at one time said in a statement to the effect that he *would prefer a*

government run by Filipinos like hell to a government run like heaven by Americans.

I remember the succession of elected Presidents, senators and local leaders. But the Philippines might not have been completely divorced from the United States with their continued presence establishing military bases in different locations in the islands.

When the Philippine senate voted to end the American military presence in the country in 1991 this could be interpreted as a vote for a truly sovereign and more independent nation. In a stricter sense we are no longer a colony, but we have not emerged fully from the shadow of its enduring role. But this showed we have a functioning government.

Philippine leaders who insist on the June 12, 1898, independence are insensitive to the facts of history. Many Pilipinos wanted to set the record straight. History of the Philippines must not be distorted. We think that it was only on July 4, 1946, when the United States granted that the Philippines became politically free as a country.

Macapagal made a statement in his speech: *I felt, too, that July 4 was not inspiring enough for the Filipino youth since it recalled mostly the peaceful independence missions to the United States. The celebration of Independence Day on June 12, on the other hand, would be a greater inspiration to the youth who would consequently recall the heroes of the revolution against Spain and their acts of sublime heroism and martyrdom. These acts*

compare favorably with those of the heroes of other nations.

This statement in my humble opinion, I regret to say was political motivation in Macapagal's mind to show his nationalistic fervor to impress the Pilipinos known for their high pride.

The Pilipinos swallowed this statement including the succeeding Presidents of the Philippines. I regret to say the political elite continues to extend to all parts of life in the country, much to the detriment. Their dominance is apparent and represses the voices of significant number of Pilipinos.

Pilipinos, not all, have been mindful of their history but have been disinterested in acknowledging their profound debt to it. They do not have an interest, making them tone deaf and considered this change of Independence Day as mundane. In my opinion, it is historical myopia.

Sad to say, there exist a twisted history on our true Independence Day, one of the most significant dates in the Philippine's history. This chapter in the history of our country must not be hidden from what is the real truth. We celebrate only what is real and factual.

Let us hope the National Historical Commission of the Philippines must take serious attention and to consider a debate on this matter.

I might request our continuing medical education (CME) director and committee members to invite someone, probably a psychiatrist with some background on this particular specialty to talk to us in our CME meetings.

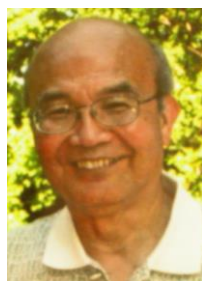

fact that in spite modest upbringing and many thorny challenges that seemed unsurmountable I able to overcome all adversities and became a doctor of medicine.

So I will talk about my own personal journey to become what my deceased father had wanted me to be. I will also share some teaching moments that I learned from my life's experiences that helped me become what I am today a retired physician, but what I am most proud of are our four children of what they have become and nine grandchildren --- the source of our pride and joy. We feel so blessed for which we are heavenly grateful for.

In about a month you will be celebrating your high school graduation. I am congratulating you, your parents and teachers for a job well done. Soon you will be embarking on a new challenge in your young lives.

Choose the school that will best prepare you in your chase of the rainbow of your dream and the school that can provide the best quality and value of your parent's hard earned money and sacrifices.

With a strong solid foundation that you have developed and acquired during your four years of high school you are well equipped to meet the challenge that may come your way.

You have been so lucky that you have lived all your lives in a city that is rich in natural beauty with bountiful natural resources that support the economic engine of the community and a city rich in history and cultural heritage. A

city whose residents have progressive vision and civic pride of what a vibrant community should be.

You are exceptionally lucky that you are in school system with dedicated and enthusiastic teachers who are among the best in the State. Your teachers, parents, and grandparents have high expectations of you.

You have a very good head start. You are very much better prepared in every way than I was at your age. I grew up at the wrong time and place.

It was World War II era when the Philippines was invaded and occupied by the Japanese. My family were in constant movement to escape from the Japanese.

We settled in a remote village where my maternal grandfather had a homestead along a small river and near the jungle for easier escape whenever the Japanese soldiers were expected in the area.

We lived on corn, small amount of rice, sweet potato and other root crops and vegetables. Instead of being in school I helped tend to pasture the family's work animals (water buffaloes), scare the parrots and wild boars from eating the green kernels of corn with a clapper made of bamboo.

I did not start formal schooling until I was 12 years old at the end of the War when our family moved from Masbate where I was born to Pangasinan my father's province was.

Masbate is an island province in the central Visayan Islands. It is in the same latitude but west of Leyte where General McArthur first landed on the beach and waded ashore

during the liberation of the Philippines, keeping his promise to the Pilipino people with his famous phrase ***I shall return.***

In a more recent event, Leyte was hit and devastated by typhoon, Haiyan killing more than 4000 Pilipinos in the island and thousands made homeless.

I was born to a family of very modest means according to Pilipino standard, but very poor in American standard way of life. My parents were teachers with salaries equivalent to \$100/month. I am the eldest of seven siblings.

We originally lived in my maternal grandmother's stilted house to protect from flood water during the rainy season when the nearby river overflow its banks. It was made of wood, bamboo and woven palm tree leaves. We had no running water. We had a drilled water well that you manually pump water from.

We had no electricity. We studied under a Coleman kerosene lamp. We slept on the floor over a mat. When I was in high school I took passenger bus, jeepney or two-wheeled horse drawn carriage (*kalesa*) to school with a lunch of cold rice, and hard boil egg, or fried dried meat or fish wrapped with weltd banana leaves.

After school we walked home 10 km (six miles?) on a gravel covered dusty road.

During my fourth year of high school, my parents were able to buy me a Columbia bike single speed with big tires, horn and battery-run head light, which I shared ride with my younger brother. I loved that

bike and had many fun and happy memories with that bike.

We never had the opportunity for any competitive sports or other extracurricular activities. We did play soccer or basketball as part of physical education class, or worked on our agronomy class vegetable garden.

After graduation from high school my father called for a sit-down family talk. He said addressing me, *Rodolfo, being the oldest child and that we are getting older I want you go into medicine so you can take care of us when we get sick.*

Actually, I was thinking going into mechanical engineering as I liked mathematics and science, and like knowing how things work. In Pilipino culture, parent's words are the laws and rule in the family.

Ironically, during my first year in medicine my father was diagnosed with advanced malignant lymphoma which at that time had no curative treatment. I was devastated. Seeing him in his sick bed in the hospital in Manila after class each day was the hardest part for me to bear. I lost my concentration and focus, my grades started to fail and I was thinking of quitting school. I was demoralized and confused.

Less than six months from diagnosis my father died. After the funeral, my mother reminded of my father's dream that his eldest son becoming a doctor. With heavy heart I tried to master new strength and resolve to fulfill my father's dream. By this time it was becoming my dream too.

Finally in 1963. I graduated with degree in medicine. I fulfilled my father's vision and dream. After passing the Philippines national medical board examination and required exchange visitors program for foreign medical graduates examination, I applied for internships at Mt Sinai Hospital in Milwaukee WI.

In 1964, I flew for the first time alone with plane ticket and \$100 pocket money given by my uncle (my father's brother who went Hawaii when he was 17 years old to work in the pineapple fields). This is my own journey. So as you see your own journey may not be always easy. Along the way there will be many distractions and temptations (excessive partying, easy access to alcohol and drugs.)

It is easy to lose focus and determination. At your young age, your endocrine glands and sympathetic system are very sensitive to swings of emotion, do not be swept away by the surge of your hormones away from your goals.

Before you take big a decision take deep breaths and close your eyes to calm your mind and body. But if you do stumble and fall down, you get back up and try even harder and the reward will be sweeter and most satisfying.

As someone has said *if I can do it so can you.*

Remember there is no substitute for hard work. I do not mean that you should not have fun. Go join your fellow students on Saturday afternoons and cheer your favorite school

teams and catch your school spirit. Good luck!

the night before his crucifixion, Jesus prays for those he will leave behind. This prayer differs from that of the prayer in the Garden of Gethsemane as portrayed in the synoptic gospels of Matthew, Mark and Luke.

This closing prayer is for all to hear and rather than a prayer of grief at his impending death, Jesus prays for those that he is to leave behind. In John's Gospel, the crucifixion is not one of humiliation but of exaltation. According to this Gospel, Jesus comes into the world, dies on the cross, is raised on the third day, then returns to the Father

so that we may know God. Simple enough. What is easy to miss is the Gospel's message that in addition to knowing God, we are expected to do God's work. Jesus leaves but we stay to continue the work that the Father entrusted to Jesus. Jesus leaves but we stay. This to me is the real *left behind* story. According to Jesus, being left behind is neither a sign of imperfect faith nor a chance to prove ourselves worthy. Being left behind is an honor, an invitation to participate in the glory of the Father. It is a commissioning into the work of the Son.

This is quite the opposite of what is being suggested in a popular series of books entitled *Left Behind* written by Tim LaHaye, recently presented as a movie. The series is based on an interpretation of the books of Isaiah, Ezekiel and Revelation. It tells the story of the end times in which many have been taken up or *raptured*, leaving the world in chaos. In this chaotic situation, a Romanian politician named Nicolae Jetty Carpathia rises to become Secretary-General of the United Nations, promising to restore peace and stability to all nations. Carpathia is actually the Antichrist allegedly foretold in the bible. A small band of born-again Christians, Rayford Steele, his daughter Chloe, their pastor Bruce Barnes, and young journalist Cameron *Buck* Williams begin their quest as the so-called Tribulation Force to help save those left behind and prepare for the coming Tribulation when God will rain down judgment of the world for seven years. Although touted as

fiction, the books' use of biblical language make them so believable that they have sold more than 60 million copies, mostly in the Western world. The problem is that the author would like us to believe that those *left behind* are to suffer God's judgment.

Works like the *Left Behind* series add to the current preoccupation of the average person with the end times as they are also preached and predicted even as Jesus says, *But about that day and hour no one knows, neither the angels in heaven, nor the Son, but only the Father. Matthew 24:36*

Many of us become preoccupied with preparing for impending doom. Just look at how much energy was focused on the recent failed prediction of the end of the world by Harold Camping, how much money was spent in its global information campaign, how many people actually quit their jobs, gave away their possessions and wait for doomsday that never came.

Not only does John's Gospel make it clear that those left behind are commissioned to continue God's work, but it also defines what eternal life means. To the Gospel writer, eternal life does not necessarily mean escaping the fires of hell or singing praises to God with the angels at some future time. It means being in relationship with God in Christ. It means knowing God through Christ. This relationship is available to us here and now. It is not that an intimate knowledge of God and Christ leads to eternal life. Knowledge of God and Christ

in our minds, in our hearts and in our souls is eternal life itself.

Eternal life, glory, and relationship with God are not things waiting out there somewhere but instead are all around us. Where? In doing what Jesus does – healing, feeding, caring, listening, sharing, making the grace of God known through how we lead our lives. The Evangelical Church in America adopts a work ethic that says it best: *God's work, our hands*. From a global perspective, *God's work, our hands* translates into supporting global ministries like the Lutheran World Relief's campaign against malaria, World Hunger, organized disaster relief here and abroad. Closer to home, the missions organized by medical societies to the Philippines provide indigent care in underserved areas. Now imagine that the ordinary and mundane things that we do everyday are also works that honor the Father – at home, at work, at play, at school; in our professions as teachers, nurses, members of the Armed Forces, farmers; in our vocations as homemakers, as parents. Any honest work that helps care for this world and the people God so loves allows us to participate in the glory that Jesus talks about.

You might try this sometime – write down the ordinary things that you are able to do that helps care for God's people and his creation. What is your passion? Is it family? Neighbor? Helping the poor? Accompanying those in grief? Let me give you an example of what people can do. Texas and Oklahoma have been hit hard

by torrential rains and tornadoes. Major flooding has destroyed homes and many people have lost their lives. People from many places rushed to victims' aid through donations of food, clothing and volunteering in rescue and recovery operations. Rest assured that many more will help in the reconstruction of property in the months to come selflessly contributing their time, talents and treasures a worthy cause.

Some of us believe that life is simply practice for the next one. Others believe that it is some kind of trial to be endured until a future glory, as a test to prove ourselves worthy of heaven. Yes, there are trials and things can be difficult, confusing and discouraging. John's Gospel gives us a two-fold promise – that God is with us to help us persevere and flourish and that God intends us to be committed to this world, its people, here and now. Glory, eternity, relationship with God – these are always in the present tense in the Gospel and we are commissioned and blessed to participate in this work and share in this amazing promise.

The PMAC and PMACA will also hold elections of board governors.


An 11:00-am mass will be celebrated.
